

Frequently Asked Questions

What are the Dues?

Dues are \$36 a year. They are used for publishing the news letter, picnic supplies, assisting with some activities, insurance and other business expenses incurred by the Club.

How are they pro-rated?

The GOCC year begins in April. If you are voted in at the April meeting you pay \$36 or the full amount. Three dollars a month are deducted thereafter.

A majority vote at a general meeting with the prospective member in attendance.
